Subject : Change in rules for admission to B.Arch Course for A Y 2017-18

The Information Brochure for admission to Full Time Professional Undergraduate Technical Courses for Academic Year 2017-18 is published on the website of the directorate. The rules are amended as per the communication from Council of Architecture, New Delhi vide their letters No.CA/2017/NATA-2017 dated 12.6.2017 and No. CA/28/NATA-2017 dated 15.6.2017 and the ammended rules are as follows:

A. Rule 7(7) Eligibility Criteria:

First Year Architecture

(1) Maharashtra State Candidature Candidate, All India Candidature Candidate, Jammu and Kashmir Migrant Candidate. -

Instead of

“(iii) The Candidate should have obtained at least 40% marks at National Aptitude Test in Architecture (NATA), conducted by the Council of Architecture;”

read as

“(iii) The Candidate should have obtained at least 40% marks at National Aptitude Test in Architecture (NATA) 2016, conducted by the Council of Architecture;

or

(iii) The Candidate should have obtained at least 35% marks at National Aptitude Test in Architecture (NATA) 2017, conducted by the Council of Architecture and declared as qualified;

or

(iii) The Candidate should have obtained marks in JEE(Main) Paper II;”

B. Rule 8(4) Assignment of Merit Number for various Courses.- (f) For admission to First Year Architecture.-

Instead of

“(i) The merit list for the Candidates at 5(1), 5(2), 5(3) and 5(6) shall be prepared on the basis of marks or score secured by the Candidate in the NATA conducted by the Council of Architecture applicable for the year 2017-18, by giving 50% weightage to CET Score and 50% weightage to HSC aggregate Marks for the purpose of admission to these Courses;”

read as

“(i) The merit list for the Candidates at 5(1), 5(2), 5(3) and 5(6) shall be prepared on the basis of normalised marks or score secured by the Candidate in the NATA conducted by the Council of Architecture or JEE(Main) Paper II applicable for the year 2017-18, by giving 50% weightage to CET Score and 50% weightage to HSC aggregate Marks for the purpose of admission to these Courses (The detailed procedure to be adopted for normalisation shall be published on the website);”

The other rules remains unchanged.
